Terms of Agreement

Distributors and Drink Life Beverages Inc. Accept the following terms and Conditions

1. Legal Age

The Distributor must be 18 years old or older to participate in this agreement, or the age of majority as stipulated in the states in which the distributor resides.

2. Independent Contractor

The company, Drink Life Beverage, agrees by this contract with the Distributor that the relationship is one of, only and exclusively an independent Distributor of the company, Drink Life Beverage, and NOT ONE OF AN EMPLOYEE, agent or franchise, member, or part owner of Drink Life Beverage Inc.

3. Acceptance

This contract will take effect upon being received by Drink Life Beverage. in its Central office. The Distributor can buy Alkaline Vine Water at the wholesale price. Drink Life Beverage Inc. reserves the right at its sole discretion, to reject and Distributor contract. Upon acceptance by Drink Life Beverage the Distributor will have the right to sale Alkaline Vine Water, as well as, to participate in any other Drink Life Beverage incentive plan.

4. Responsibilities of the Independent Distributor

The Distributor is fully and solely responsible to follow all the laws or regulations related to their business in any jurisdiction when conducting this business including the responsibility to apply for, and obtain the necessary licenses for their business, to receive and to pay taxes and the sales and purchases and complying with all others state or federal regulations, as well as, the federal or local laws and statues which apply to this business.

5. Termination of Contract

By terminating the contract, the Distributor will lose rights to buy Alkaline Vine at the Distributor price, will lose all their Distributor rights including any and all future payments, and will discontinue the use of all trade names, services and proprietary information of Drink Life Beverage.

6. Taxes

Distributor is responsible for his or her own taxes (state, local and federal)



7. Promotion and Marketing

The Distributor is responsible for sales promotion activities and independent distribution. The products will have names assigned by Drink Life Beverages and they will be identified like the products that Drink Life Beverage sales through independent Distributor.

8. Trademarks

The Distributor agrees and recognizes by this contract that they do not have the right to the trademarks and service marks of Drink Life Beverage and Alkaline Vine. The Distributor agrees not to take any action that goes against the exclusive ownership of these trademarks and service marks.

9. Distribution

The Distributor will not use, nor will they provide to clients any material that is not approved and printed by Drink Life Beverages, to use in relation to the sale of products. In no case will the Distributor remove product package or correct information labels on any of the products destined for the client. The alteration of such will be the responsibility of the independent Distributor.

10. Product Acceptance

The Distributor will inspect all products immediately upon receipt to verify that there are not any damaged products in the shipping
The Distributor must make a claim within 2 days to Drink Life Beverages.

11. Payment

The Distributor has to pay the shipping cost of the order at the time of placing the order, in order to receive the order from Drink Life Beverages

12. Limitation of Responsibility to Distributor

In spite of any contrary disposition contained in this contract, in no case will Drink Life Beverages be liable for indirect, incidental, consequential damages, and in no cases will the liability of Drink Life Beverages that arises with any product exceed the actual amount paid by the Distributor for each product

13. Proprietary Rights

The Distributor agrees not to use the names of Drink Life Beverages, logos, trade names, or other property of Drink Life Beverages without previous written consent.



14. Indemnification and/or Cancellation

The Distributor agrees to indemnify and to hold harmless Drink Life Beverages, its officials, employees, shareholders, directors, in relation to any allegations, demands or obligations, civil responsibilities, loss, cost, or fee including, but not limited to, cost or legal processes, or lawyer fees, which they may incur directly or in the following actions: **a.)** your distributor's activities **b.)** violation of the condition of this contract **c.)** the violation or failure to comply to anyone, with the applicable federal, state or local laws. Drink Life Beverages will have the right to withhold any compensation, any amount that the Distributor may owe Drink Life Beverages from the amount of income that the Distributor has earned.

15. Assignments

The Distributor understands that the contract cannot be transferred nor be assigned without previous written consent to Drink Life Beverages.

16. Contract Changes

The Distributor understands that Drink Life Beverages can change at any time and without previous warning this contract, the rules and regulations, the Distributorship Agreement and the prices of products and any information published by the company. These changes will take effect all the moment of publication or transmission of these changes by means of official company publications.

17. Confidentiality

The Distributor agrees not to disclose to anyone from the termination of this contract any information on markets, clients, commercial systems, policies of Drink Life Beverages or the manufacturing or distribution of Drink Life Beverages or in general any information that the Company disclose in confidence to the Distributor.

18. Agreement

The contract constitutes the total agreement between the Distributor and Drink Life Beverages, canceling any previous agreement between the parties.

19. Signature
